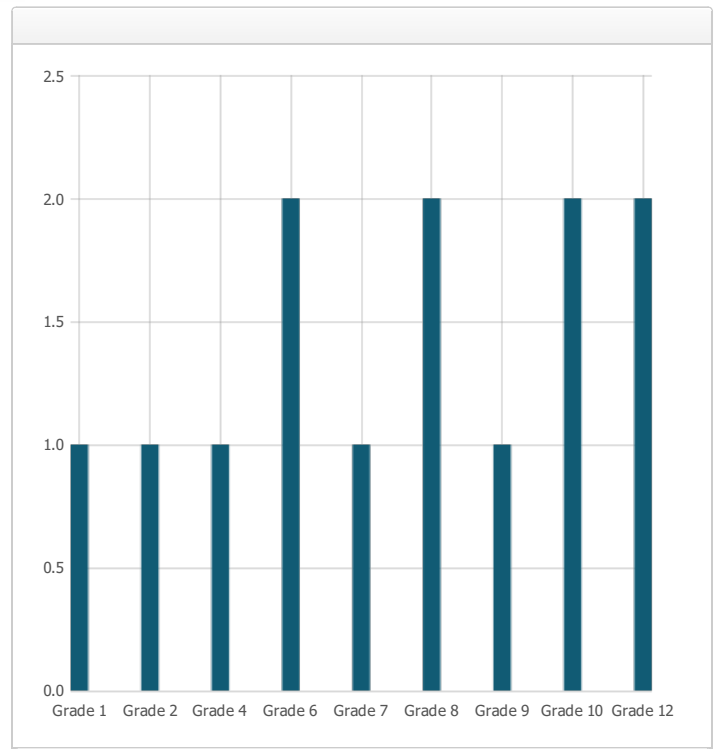
School Description and Mission Statement (School Year 2016-17)

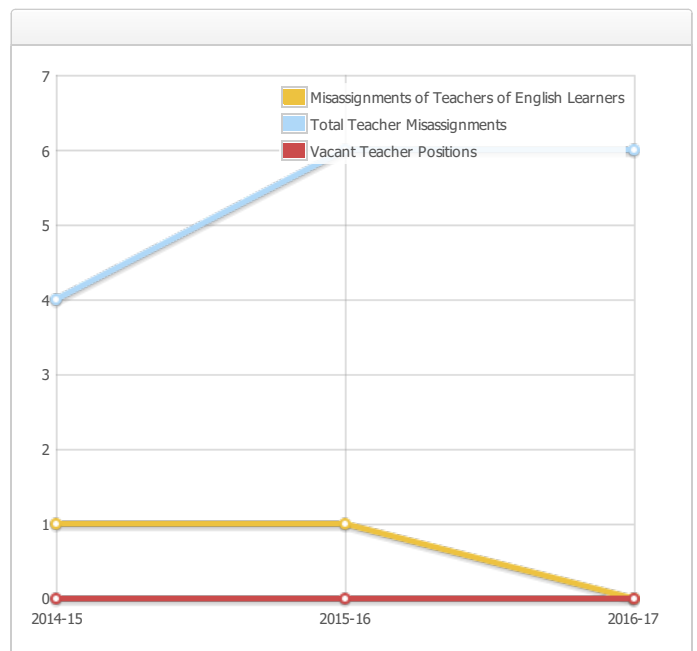
